ROUTES OF EXPOSURE: Absorbed through skin. Eye contact. Inhalation. Ingestion.

EFFECTS OF A SINGLE (ACUTE) OVEREXPOSURE:

INHALATION: Overexposure to concentrations moderately above the threshold Limit Value (TLV) of 25 ppm for ammonia may cause irritation of the eyes, nose, and throat. Higher concentrations may cause breathing difficulty, chest pain, bronchospasm, pink frothy sputum, and pulmonary edema. Overexposure may predispose to the development of acute bronchitis and pneumonia. This gas mixture may also cause asphyxiation.

SKIN CONTACT: This product is a gas.

SKIN ABSORPTION: Prolonged or widespread skin contact with the liquid may result in the absorption of harmful amounts of material.

SWALLOWING: An unlikely route of exposure. This product is a gas at normal temperature and pressure, but may cause chemical burn of the mouth, throat, oesophagus and stomach.

EYE CONTACT: This product is a gas.

EFFECTS OF REPEATED (CHRONIC) OVEREXPOSURE:

Chronic exposure may cause chemical pneumonitis and kidney damage.

OTHER EFFECTS OF OVEREXPOSURE:

None currently known.

MEDICAL CONDITIONS AGGRAVATED BY OVEREXPOSURE:

Inhalation may aggravate asthma and inflammatory or fibrotic pulmonary disease. The skin irritating properties of this material may aggravate an existing dermatitis.

Not listed as carcinogen by OSHA, NTP or IARC.

4. First Aid Measures

INHALATION:

Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, qualified personnel may give oxygen. Call a physician.

SKIN CONTACT:

Immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Discard clothing and shoes. Call a physician.

SWALLOWING:

This product is a gas at normal temperature and pressure. Rinse mouth with water. Give at least two glasses of water or milk at once. Do not induce vomiting. Call a physician.

EYE CONTACT:

This product is a gas.

NOTES TO PHYSICIAN:

Victims of overexposure should be observed for at least 72 hours for delayed onset of pulmonary edema. The hazards of this material are mainly due to its severe irritant and corrosive properties on the skin and mucosal surfaces. There is no specific antidote, and treatment should be directed at the control of symptoms and the clinical condition.

CO2, dry chemical, water spray or fog.

SPECIAL FIRE FIGHTING PROCEDURES:

WARNING Evacuate all personnel from danger area. Do not approach area without self-contained breathing apparatus and protective clothing. Immediately cool containers with water spray from maximum distance taking care not to extinguish flames. Remove ignition source if without risk. If flames are accidentally extinguished, explosive re-ignition may occur. Reduce corrosive vapours with water spray or fog. Stop flow of gas if without risk while continuing cooling water spray. Remove all containers from area or fire if without risk. Allow fire to burn out.

UNUSUAL FIRE AND EXPLOSION HAZARD:

Toxic, corrosive gas. Container may rupture due to heat of fire. Do not extinguish flames due to possibility of explosive re-ignition. Corrosive vapours may spread from spill. Explosive atmospheres may linger. Before entering area, especially confined areas, check atmosphere with appropriate device. No part of a container should be subjected to a temperature higher than 52 C.

6. Accidental Release Measures

STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED:

WARNING! Corrosive, toxic gas. Immediately evacuate all personnel from danger area. Use self-contained breathing apparatus and protective clothing where needed. Reduce vapours with fog or fine water spray. Reverse flow into cylinder may cause rupture. Shut off leak if without risk. Ventilate area of leak or move leaking container to well ventilated area. Prevent runoff from contaminating surrounding environment. Corrosive, toxic vapours may spread from spill. Before entering area, especially confined areas, check atmosphere with appropriate device.

WASTE DISPOSAL METHOD:

Prevent waste from contaminating the surrounding environment. Keep personnel away. Discard any product, residue, disposable container, or liner in an environmentally acceptable manner, in full compliance with federal, provincial, and local regulations. If necessary, call your local supplier for assistance.

7. Handling and Storage

PRECAUTIONS TO BE TAKEN IN STORAGE:

Store and use with adequate ventilation. Firmly secure cylinders upright to keep them from falling or being knocked over. Screw valve protection cap firmly in place by hand. Store only where temperature will not exceed 52 C. Store full and empty cylinders separately. Use a first-in, first-out inventory system to prevent storing full cylinders for long periods.

PRECAUTIONS TO BE TAKEN IN HANDLING:

Protect cylinders from damage. Use a suitable hand truck to move cylinders; do not drag, roll, slide, or drop. Never attempt to lift a cylinder by its cap; the cap is intended solely to protect the valve. Never insert an object (e.g., wrench, screwdriver, pry bar) into cap openings; doing so may damage the valve and cause a leak. Use an adjustable strap wrench to remove over-tight or rusted caps. Open valve slowly. If valve is hard to open, discontinue use and contact your supplier.

OTHER HAZARDOUS CONDITIONS OF HANDLING, STORAGE, AND USE:

Toxic, corrosive high-pressure gas. Do not breathe gas. Do not get vapour in eyes, on skin, or on clothing. Have safety showers and eyewash fountains immediately available. Use only in a closed system. Use piping and equipment adequately designed to withstand pressures to be encountered. Store and use with adequate ventilation. Close valve after each use; keep closed even when empty. **Prevent reverse flow.** Reverse flow into cylinder may cause rupture. Use a check valve or other protective device in any line or piping from the cylinder. **When returning cylinder to supplier,** be sure valve is closed, then install valve outlet plug tightly. **Never work on a pressurized system.** If there is a leak, close the cylinder valve. Vent the system down in a safe and environmentally sound manner in compliance with all federal, provincial, and local laws; then repair the leak. **Never place a compressed gas cylinder where it may become part of an electrical circuit.**
